A signal phrase introduces information borrowed from a source in the form of a quotation, summary, paraphrase, or fact. Usually, the signal phrase includes the author's name.

A few general rules for MLA citations: • Authors' names are inverted (Last name, First name); for each additional author, use traditional name order. • Every line after the first must be indented one inch (hit Tab key once).

The format of dates is: Day Month (shortened) Year. E.g. 5 Sept. 2012. Whether to give the year alone or include a month and day depends on your source: write the full date as you find it there. If no date is listed, omit it unless you can find that information available in a reliable source.
